_____ **Power Mover Seller (bulk sell your parts to one buyer at a time)**

- I agree to offer and sell my idle parts at 50 cents on the dollar of the last published cost in the MFG parts book.
• I will also pay the shipping costs to transport the parts to the buyer's facility.
• I understand that I can review all opportunities to sell my parts before they are presented to the buyer. I will have up to 3 business days to review the step 1 offer or it will be cancelled.
• I agree to notify buyers if an actual part number (on the box) is different from the part number shown on the line. (for example, superceded parts)
• Parts sold will be in original, undamaged or unmarked OEM packaging unless otherwise noted up front.
• Buyer may return shipped parts (at sellers expense) that are not in condition as noted above.
• I will accept a purchase order from the buyer for sale of the parts. Buyer will pay seller in NET 30 terms, once parts are received and accepted.
• I will ship the parts out within 10 business days of the date the buyer accepts the order. (Step 3)
• A1 Parts Mover LLC., will bill me on a commission basis. An invoice will be generated for me at the end of the month for all completed offers and I will pay the invoice in NET 15 terms. I am choosing the checked option below.

_____ I accept billing on a commission basis and will pay 5% of the dealer cost of all parts that I sell through the A1 Parts Mover LLC network. An invoice will be generated for me around the 30th of each month for all completed offers and I will pay the invoice in NET 15 terms.

_____ **Power Mover Buyer (bulk buy parts from one seller at a time)**

- I agree to purchase parts from sellers at 50 cents I the dollar of the last published cost in the MFG parts book (the cost of the parts will be determined from the buyers submitted data).
• I understand that each line item on a parts offering is subject to review and acceptance by me.
• I can reject parts that are not current part numbers (superceded)
• I can reject parts that are not in original and unmarked OEM packaging unless noted upfront.
• I will review all offers (step 2) that are presented to me in 3 business days or less.
• I will submit a purchase order to the seller upon acceptance of the offers.
• I will make payment to the seller with NET 30 terms upon receipt and acceptance of the parts.
• Upon receipt of the parts, I will update the A1 Parts Mover website with the final amount of the purchase and finalize the offering. (Step 4)
• I will pay A1 Parts Mover LLC a 5% commission on the dealer cost of total parts purchased on each offer. (not the discount amount).
• I will receive an invoice from A1 Parts Mover via email around the 30th of each month and agree to pay the invoice in NET 15 terms.
